#### Scope

This Policy applies to all of MetFilm School's campuses and covers all students on-campus, online, onstage and applies to all stages of the learning process, i.e. pre-entry, on course and at exit.

## **Mission Statement**

MetFilm School will partner individuals, communities and businesses to achieve outstanding education and training successes. Our aim is to ensure every student has the chance to fulfil his or her potential.

MetFilm School is committed to the active promotion of Equal Opportunities and positive regard for all students. Everyone within MetFilm School will be expected to work to these principles and promote its philosophy.

### **General Principles**

MetFilm School will, within the resources available:

#### **Positive Action**

#### Redress
